INTRODUCTION

- 1. This Statement of Common Ground has been prepared by Maidstone Borough Council ('MBC') and Kent County Council ('KCC') acting in its capacity as Minerals and Waste Planning Authority for Kent.
- This Statement outlines an agreed position in regards to the minerals safeguarding issues raised at paragraph 2.13 of KCC's Regulation 20 representations to the Maidstone Borough Local Plan (MBLP) 2011 – 2031 dated 18 March 2016.
- 3. Officers from MBC and KCC met on 22 April 2016 to discuss the minerals safeguarding issues raised in KCC's representation and the potential implications for the MBLP. Subsequently, the Kent Minerals and Waste Local Plan (KMWLP) 2013 2030 Inspector's Report was published on 26 April 2016 and the Report and Main Modifications provided additional clarity on the final wording of minerals safeguarding policies in the KMWLP.
- 4. Officers from MBC and KCC met again on 11 May 2016 to discuss the implications of the KMWLP Inspector's Report and to agree on the measures required to satisfactorily address mineral safeguarding issues through the MBLP. During the meeting it was agreed that it would be helpful to set out these measures through a Joint Position Statement, with the aim of assisting the Inspector during the Examination of the MBLP. It was also agreed that KCC would provide a background information note on mineral supply and safeguarding and the relevant economic geologies in the Maidstone Borough area to aid understanding of mineral matters that are available in the public domain¹. A copy of the Information Note is appended to this Statement.

- 5. The KMWLP was adopted by KCC on 14th July 2016.
- 6. On 29 July 2016, KCC provided MBC with an Information Note (Appendix 1) in order to assist MBC in its preparation for the MBLP Examination. The Note describes the nature, history and broad economic viability of the minerals located within the MSAs which affect Maidstone Borough. The Note also sets out the landbank considerations for aggregate minerals against National Planning Policy Framework (NPPF) requirements where relevant and the safeguarding matters for all minerals within the Maidstone Borough area.

Matters Agreed

7. Minerals safeguarding is a matter for all planning authorities. There are a number of Policies
in the adopted Kent Minerals and Waste Local Plan 2013-30 with respect of safeguarding.
These are as follows:

Policy CSM 5: Land-won Mineral Safeguarding

Policy CSM 6: Safeguarded Wharves and rail Depots

Policy CSM 7: Safeguarding Other Mineral Plant Infrastructure

Policy CSW 16: Safeguarding of Existing Waste Management Facilities

Policy DM 7: Safeguarding Mineral resources

Policy DM8: Safeguarding Minerals, Transportation, Production & Waste management Facilities

Policy DM 15: safeguarding of Transportation Infrastructure

Policy DM 7 sets out a series of exemptions from the presumption to safeguard mineral resources.

8. It is agreed that KMWLP Policy DM7 would apply to development proposals identified in the MBLP, where these are located within the identified MSAs, and therefore the MBLP should include some additional explanatory text to outline the purpose of MSAs and the relationship between the MBLP and the KMWLP (Proposed Change MS1). Reflecting the conclusions outlined in the KMWLP Inspector's Report, and the subsequent adopted Plan, it is further agreed that a map showing the extent of the MSAs should be included in the MBLP (Proposed Change MS2).

- 9. It is agreed that exception criterion (7) in KMWLP Policy DM7 (*"it constitutes development on a site allocated in the <u>adopted</u> development plan"*) may be interpreted so as to exempt the requirement for mineral assessments to be undertaken for affected development allocations in the MBLP. An additional policy change is proposed to the MBLP to confirm the requirement for mineral assessments on sites not currently in an adopted local plan as set out at **Proposed Change MS3**. It is therefore agreed that additional policy criterion should be included for affected sites, as set out at Proposed Change MS3, to reflect the need for a minerals assessment to be undertaken as part of any planning application
- 10. Officers from MBC and KCC have worked constructively to address the issues raised at paragraph 2.13 of KCC's Regulation 20 representations to the MBLP. It is agreed that Proposed Changes MS1, MS2 and MS3 will together overcome these concerns to ensure that the MBLP is in conformity with the KMWLP in respect of proposed allocations located within the following MSAs:
 - Building Sands: Folkestone Formation;
 - Sharp Sands and Gravel Aggregates: Sub-Alluvial River Terrace Deposits and River Terrace Deposits; and
 - Building Stone: Palundina Limestone.

Matters Not Agreed

1. KCC considers that **Proposed Change MS3** should be applied to all proposed allocations affected by all MSAs identified within Maidstone Borough. MBC does not agree that **Proposed Change MS3** should be applied to proposed allocations affected by the following MSAs:

- Hard Rock: Hythe Formation Kentish Ragstone; and
- Industrial Sands Sandgate Formation.

KCC considers that **Proposed Change MS3** should apply to all safeguarded geologies and that Policy H1 should be amended to include an additional criterion:-

at 1 (vi) to read "Development proposals which fall within the Minerals Safeguarding Areas as shown on the policies map will be required to undertake a minerals assessment to assess the viability and practicability of prior extraction of the minerals resource. The minerals assessment will comply with Policy DM7 of the Kent Minerals and Waste Local Plan (2013-2030) and any supplementary planning guidance produced by the Minerals Planning Authority in respect of minerals safeguarding."

And; Policies: H2 (2), RMX (1), RMX (4), EMP1 (2), EMP1 (5), GT1 (1), (2), (4) : should be amended to include an additional criterion :-

"Minerals Safeguarding – This site falls within the Minerals Safeguarding Areas as shown on the policies map and therefore development proposals will be required to undertake a minerals assessment to assess the viability and practicability of prior extraction of the minerals resource. The minerals assessment will comply with Policy DM7 of the Kent Minerals and Waste Local Plan (2013-2030) and any supplementary planning guidance produced by the Minerals Planning Authority in respect of minerals safeguarding."
